Both worked with the Centre's data archive of public opinion research to become familiar with the methods used to make the data accessible. They also carried out their own research programs and prepared articles for publication in Ukraine.

Drs. Bekeshkina and Makeyev will apply their new knowledge in Ukraine in part by helping with the facilitation of a series of workshops - The Media, Public Opinion and the State. These workshops, supported by Partners in Civil Society, will be held across Ukraine for journalists, other media people and political analysts prior to the upcoming national elections.

Two Canadian volunteers, Chris Coulter and Natalie Mychajlyszyn, have completed three-month assignments with Democratic

Initiatives, and a third started at DIF in May. The Canadian volunteers, all of whom have Ukrainian roots, are regarded highly at DIF, providing much-needed middle-level management support and training. Their work has included assisting with the preparation of proposals for service contracts and helping DIF staff and associates improve their English and work on international communications. One volunteer has directly helped DIF obtain contracts to conduct surveys and organize conferences for NATO and the Canadian Cooperatives Association and Council of Ukrainian Credit Unions of Canada.

Aside from such practical assistance and capacity development, Mr. Kucheriy believes that the volunteers provide an extremely valuable service in helping to build bridges "Thorough discussions between cultures. help DIF to understand democratic developed countries like Canada and also help us see

Ukraine through Canadian eyes. It is also important for DIF to start to understand the particular style of behavior of Canadians (as opposed to people from other countries)." He adds, "One goal for DIF is to integrate itself into the international community", and the Canadian volunteers are helping with this.

The first Canadian volunteer at DIF writes, "Ukraine's recently-identified strategic importance by countries like the United States, together with all of the concomitant aid associated with such recognition, is not sufficient to ensure Ukraine's smooth transformation to a democratic society. First and foremost, this transformation must be accomplished by Ukrainians for Ukrainians in order to be successful. Secondly, if these reforms are to be long-lasting and selfsustaining, a greater effort must be mounted to create and foster a strong, dynamic civic culture in Ukraine. Support provided to DIF satisfies both of these conditions."
