
# **Canada-Ukraine Foundation: Getting Ready to Roll**

A new executive of the Canada-Ukraine Foundation has actively started pushing to get the Foundation off the ground. Over two weekends in late January and early February, working groups were assembled, one in Edmonton, and a second in Toronto. While the overall concept for this charitable foundation is to provide assistance to Ukraine, the logistics of its mandate are still being ironed out. These two brainstorming sessions included Ukrainian community leaders, project managers and participants from technical cooperation and humanitarian projects to Ukraine, as well as a representative from CIDA.

The discussions are helping define community needs in terms of working with Ukraine, as well as possible avenues of funding and fundraising. Topics included a "Partnership Program " for Ukraine, and "block" and "cluster" funding for community projects through CUF from CIDA. Representatives from the education sector in patricular voiced their concern that, since education is a Canadian provincial jurisdiction, there is a lack of national coordination and overall strategy for education projects. This is compounded by the fact that education as such is not specifically defined as one of CIDA's priorities for Ukraine.

While much work lies ahead for the Foundation, both forums ended on an optimistic note. In the words of Andrew Semotiuk, President, the preliminary discussions must now lead to solid strides forward with "CPR", namely, cohesion, professionalism, and ultimately results.
