## His Excellency Victor Batyuk Ukraine's New Ambassador to Canada

On January 6, 1994 the President of Ukraine Leonid Kravchuk appointed His Excellency Mr. Victor H. Batyuk as Ambassador Extraordinary and Plenipotentiary of Ukraine to Canada. Since March 1992, Ambassador Batyuk had been the Permanent Representative of Ukraine to the United Nations.



Mr. Batyuk has been in his country's diplomatic service since 1962. From 1984 to 1992 he served as a member of the Board and Director of the Department of International Organizations at the

Ministry of Foreign Affairs. He was Ukraine's Permanent Representative to the United Nations Office in Geneva and other international organizations in Geneva from 1978 to 1984. Mr. Batyuk's previous assignments include posts of Secretary General at the Ministry of Foreign Affairs (1974-1978); Assistant to the Minister of Foreign Affairs (1973-1974); Second Secretary at Ukraine's Permanent Mission to the United Nations (1968-1973); and Third, Second, and First Secretary at the Ministry of Foreign Affairs (1962-1968). In 1964 Mr. Batyuk was a fellow at the Institute for Labour Studies of the International Labour Organization (ILO). He was a student at Moscow State Institute for International Relations from 1956 to 1962. As a member of Ukrainian delegations, Mr. Batyuk participated in numerous international meetings. He is also a member of the Ukrainian Writer's union and has published translations of Bangladeshi, Indian and United States literature. Mr. Batyuk, who was born on March 1, 1939, is married and has three children.

The security of Ukraine is linked to the prosperity of the people. Our involvement there, is not only a political one, but also an economic one. Canada already has a Trade Commissioner in Kyiv and solid programs to expand trade. The Program for Export Market Development helps Canadian exporters tap new and expanding markets, such as Ukraine. Our Renaissance Eastern Europe program provides funding to set up Canada-Ukraine joint ventures. We are also helping Ukrainian firms show their products and make contacts with Canadian business. Through our Trade Facilitation Office, we are offering exporter assistance programs, including seminars on how to sell in the Canadian market.

• Canadian businesses wishing to initiate trade with Ukraine have indicated that an expansion of Canada's physical presence in Ukraine is crucial to assist them with the process. Can you indicate what initiatives or plans you foresee for Canada's Embassy in Kyiv in these matters? Are there plans for any additional Consulate or Trade Missions in Ukraine, eg, in Lviv, Western Ukraine?

Work on the chancery in Kyiv is virtually complete. All staff have moved in and are now working under one roof. This makes the Embassy more effective in pursuing Canadian interests and delivering services to Canadians in Ukraine. We have added a technical assistance section to the
